How It Works

Each DAF must be tied to a sponsoring charity to provide donors with a tax deduction. Ren partners with various sponsoring charities, including the Renaissance Charitable Foundation. Your financial advisor can confirm if Ren supports the DAF program at their financial institution, and if not, you can get a DAF directly via Renaissance Charitable, where your advisor is still free to invest the assets according to your strategy.
